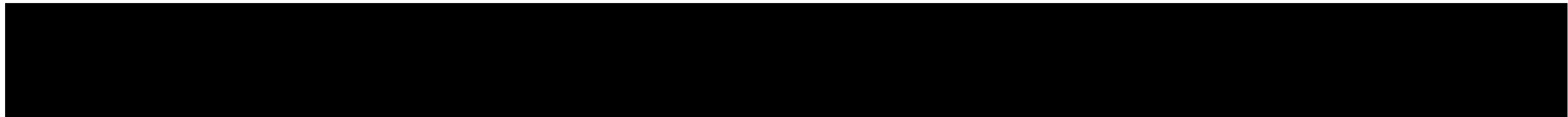

Our 2021 Call for Applications is open from 21 June 2021 until 1 August 2021 (18:00 CET).

PLEASE NOTE: FOR SECURITY PURPOSES WE WILL ONLY ACCEPT APPLICATIONS THROUGH OUR ONLINE SYSTEM

Review our 2021 documents carefully! Our funding criteria and priorities remain the same, however our procedures have been updated to improve accessibility, security and safety of our applicants.

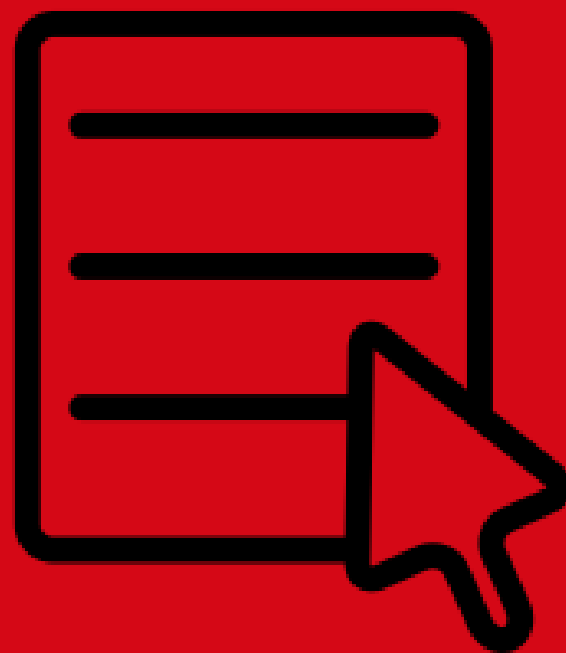

Red Umbrella Fund Grantmaking Criteria

Each year dozens of applications are submitted by organisations that are not eligible for a Red Umbrella Fund Grant. In order to assess whether your organisation is eligible prior to proceeding to the application, please answer the following eligibility questions.
